TRADE STANDARDS AND QUALITY CONTROL ACT 1992

Trade Standards (Fuel Standards) (Amendment) Order 2018

IN exercise of the powers conferred on me by section 26 of the Trade Standards and Quality Control Act 1992, and having considered the recommendation of the Trade Standards and Quality Control Advisory Council and thinking that it is in the public interest to do so, I hereby make this Order—

Short title and commencement

- 1.—(1) This Order may be cited as the Trade Standards (Fuel Standards) (Amendment) Order 2018.
 - (2) This Order comes into force on 1 January 2019.
- (3) In this Order, the Trade Standards (Fuel Standards) Order 2007 is referred to as the "Principal Order".

Order 1 amended

- 2. Order 1 of the Principal Order is amended after paragraph (3) by inserting the following new paragraphs—
 - "(4) The obligations in respect of the manufacture and import of fuel 10ppm (diesel) and 50ppm (unleaded petrol) under this Order come into force on 1 January 2019.
 - (5) The obligations in respect of the manufacture and import of unleaded petrol to reduce the sulphur content to 10ppm come into force on 1 January 2021.".

Schedule 1 amended

- 2. Schedule 1 to the Principal Order is amended by—
 - (a) in paragraph 4—
 - (i) in subparagraph (1) in item 1 of Table 1, deleting "500mg/kg" and substituting "10mg/kg";

- (12) Flash point min 66°C.";
- (b) in paragraph 5(1) after item 7 of Table 2, inserting the following new items—
