## CALL FOR WRITTEN SUBMISSIONS – ESTABLISHMENT OF THE MEDICINAL CANNABIS INDUSTRY IN FIJI

The Ministry of Trade, Co-operatives and Small and Medium Enterprises, and Communications ('Ministry') will hold public consultations on 9 October 2023 to 19 October 2023 to address the socio-economic impacts of the emerging industry.

The consultations will be held to consider views on the establishment of the Medicinal Cannabis industry in Fiji. In introducing this industry and with thorough consultations, Fiji will be able to meet the demand of the global market whilst promoting economic diversification. The Ministry would like to call for submissions on the following:

- Legal pathway for medicinal cannabis in Fiji (trade exports only);
- Possible tax on export of medicinal cannabis; and
- Monitoring and enforcement mechanisms.

The Ministry would like to reiterate that the establishment of a medicinal cannabis industry in Fiji will be limited to **exportation only** and will not affect the domestic prohibition of Cannabis in Fiji.
